- Appointing Designated Child Welfare Officers in the club to support implementation and provide support.
- Providing appropriate rules for the protection of children in line with a code of ethics and the FAI best practice guidelines.
- Appointing a Child Welfare Sub-Committee made up of the DLP and Children's officer responsible for overseeing the FAI's policy on child protection and its implementation;
- Providing a clear pathway for the investigation of complaints and appropriate disciplinary procedures;
- Providing codes of practice and templates for all members
